With Committee members retiring and new members on board we felt it would be sensible for us all to fully understand the policy. It is, in general terms, the same as the Ramblers Insurance Policy so we do not expect any changes to be required.

We have been reviewing the 'Guidelines for Walk Leaders' and 'Guidelines for Walkers' and have developed a 'Code of Conduct' for Group members. Copies of the updated Guidelines and of the Code of Conduct accompany this Newsletter; the documents will also be available to view on the website.

In the event of an incident occurring on a walk, the Emergency Services like to be given a **what3words** location as it pinpoints a location with outstanding accuracy. To that end we encourage everyone to upload the APP. Further information will be forthcoming regarding w3w, O.S. maps for grid reference etc in the near future.

Please note, the Members section of the MFCG website now has a new password for accessing member-specific information and documents. It is Walkntalk23. This is for paid up members use only.

So, what can be found in the Members section of the website? This is where members can see minutes from, for example, the AGM, and Committee Meetings. The Committee meets every two months or so to report on the Group's finances and membership numbers, footpath hazards and closures, progress with ongoing projects and any issues arising.
